C. Name of the bidder whose bid was rejected with reasons for their rejection:

SL No	Name of the bidder	Reasons for their rejection
1	HS Enterprise Ltd	H.S. Enterprise submitted manufacture's authorization letter of China Jialing Industrial Co., Ltd. (Group) with an address in China. The letter (Manufacturer's Authorization) stated that they were the official manufacturer of Jialing Brand Motorcycle in the factory established in China. But the catalogue submitted by the bidder was of H.S. Enterprise Limited, Bangladesh instead of China Jialing Industrial Co., Ltd. (Group). Moreover, Jialing Brand motorcycle could not be found in the list of the products of the said manufacturer's Web page (China Jialing Industrial Co., Ltd. (Group)). In the website of the manufacturer one JH100 motorbike was found but the brand name was Jalin (copy attached) instead of Jialing written on the picture submitted by the bidder. The

		website of the H.S. Enterprise shows Jialing motorcycle as one of the products marketed as its own brand name. Under the circumstances it was clear that the statements made in the so-called manufacturer's authorization letter was not true. The members of TEC termed this inconsistencies found in the Manufacturer's Authorization, catalogue and the picture of models in the web site of the manufacturer, major deviation and declared the bid non-responsive.
2	Asia Trade International	Asia Trade International was declared non-responsive because the bidder failed to meet the requirements of experience criteria of the bidder. Experience criteria required that the bidder should have been in operation satisfactorily for at least 3 years. The bidder has been found to have operated business for last one year only. The bidder also did not submit any catalogue/brochure of the said product. The bidder did not submit specification submission sheet with the bid and for that the offered specifications could not be compared with the required specifications. Finally the bidder did not extend bid validity period with bid security.
3	TVS Auto Bangladesh	TVS Auto Bangladesh failed to meet the requirements of qualification criteria of the bidder, which is vital. Experience criteria required that the main supplier within the last three years should have successfully completed a good number of contracts. Soundness of the Bidder's financial position for last three years should be demonstrated. The submitted documents reveals that the bidder has been found to have started business 2 years back and does not have the required experience.
